#### **Letter to NNHPD**

As part of the Health Products and Food Branch of Health Canada, the <u>Natural and Non-prescription Health</u> Products Directorate (NNHPD) is the regulating authority for natural health products for sale in Canada.

This is the final statement of the letter:

"Sure you will agree, having read the above, that we can no longer claim that homeopathy is "a system that science does not support.".... We continue to firmly believe in the willingness and ability of Health Canada to speak truth to Canadians and we, the signatories of this letter, want to work in that direction. This letter offers NNHPD the opportunity to be updated adequately and sufficiently so that right action can be taken immediately in order to present Canadians with a consultation document that is neutral and not misleading."
